

Summary Notification Form for Market 5/2008

"Míla conditions IPTV over Access Option 3"

Date of notification 28 March 2018.

Under the obligation in Articles 15 and 16 of the Directive 2002/21/EC (Framework Directive) and Electronic Communications Act No. 81/2003, Article 17, the Post and Telecommunications Authority of Iceland (PTA) has conducted review of Míla for IP television service (IPTV) provided at a fixed location on Access Option 3, which is a new product on the market for wholesale broadband access (Market 5/2008), based on PTA Decision no. 21/2014, dated 13 August 2014, on the relevant market.

The planned PTA Decision on conditions for IPTV on Access Option 3 was sent for national consultation on 13 December and this consultation was open until 5 January 2018
