# "Wholesale tariff for call termination in public telephone networks provided at a fixed location"

Date of notification 19 September 2018.

This form specifies the summary information to be provided by national regulatory authorities to the EFTA Surveillance Authority (ESA) when notifying draft measures in accordance with Article 7 of Directive 2002/21/EC (Framework Directive) and annex I to ESA Recommendation of 2 December 2009 on notifications, time limits and consultations.

Under the obligation in Articles 15 and 16 of the Directive 2002/21/EC (Framework Directive) and Electronic Communications Act No. 81/2003, Article 17, the Post and Telecom Authority of Iceland (PTA) has conducted a benchmarking for determining a wholesale rate for call termination on the public telephone network provided at a fixed location (Market 1). This draft decision is based on PTA Decision no. 22/2016 on the designation of companies with significant market power and on the imposition of obligations on the wholesale market for call termination in individual fixed public phone networks, dated 23 December 2016.

The draft Decision was published for national consultation on 10 August 2018 and the consultation lasted until and including 31st August 2018. The PTA received no comments from stakeholders.
