### 3. Case 73393: Non-incorporation by Iceland of Regulation (EU) No 580/2011 (European Network and Information Security Agency as regards its duration)

The College adopted a decision to issue a letter of formal notice to Iceland for failure to incorporate the Act referred to at point 5cp of Chapter I of Annex XI of the Agreement on the European Economic Area (*Regulation (EU) No 580/2011 of the European Parliament and of the Council of 8 June 2011 amending Regulation (EC) No 460/2004 establishing the European Network and Information Security Agency as regards its duration*), as adapted to the EEA Agreement by Protocol 1 thereto, into its national law, as **Decision No. 99/13/COL**


