### **2. Case 80297: College Decision 003/20/COL - Closure decision - Complaint against Norway regarding the notion of a partner in a durable relationship**

The College adopted a decision to close a complaint case arising from an alleged failure by Norway to comply with Directive 2004/38/EC by not recognising the derived residence right of a third-country national partner in a durable relationship with a Norwegian national, on the ground that she was registered as married in her home State, as Decision No. 003/20/COL.

**3. Case 81771: College Decision 004/20/COL - Closure decision - Complaint against Norway regarding the refusal to grant study financing abroad to an EEA worker on the ground that the studies are not connected with the previous work**

The College adopted a decision to close a complaint case arising from an alleged failure by Norway to comply with EEA law by requiring that studies are connected with previous work in order for EEA workers to retain their status as workers, as Decision No. 004/20/COL.
