The College adopted a decision to deliver a reasoned opinion to Norway concerning that country's breach of Articles 31 and 40 of the EEA Agreement by maintaining in force administrative practices and rules, which limit investors from owning more than 20-25 percent of the total shares in a financial undertaking and according to which the ownership of banks and insurance companies has to be dispersed by offering shares on the market, as Decision No. 010/20/COL.

6. Case 80430: College Decision 012/20/COL - Reasoned opinion - Complaint against Iceland regarding implementation of the Protocol (No 7) on the privileges and immunities of the EU in regards to handling of pension payments under Icelandic tax law
