### **2. Case 74864: College Decision 093/17/COL - Closure Decision - Complaint against Norway concerning the assessment whether a family member of an EEA national acquired the right to permanent residence**

The College adopted a EFTA Surveillance Authority decision closing a complaint case arising from an alleged failure by Norway to comply with Articles 2(2)(a), 7(2) and/or 16(2) of Directive

2004/38/EC by requiring that, in order to enjoy derived rights of residence, third country national spouses of EEA nationals should have actual family life with those EEA nationals, when the EEA nationals at issue are still enjoying their rights of residence in Norway, as Decision No. 093/17/COL.

### **3. Case 80146: College Decision 100/17/COL - Reasoned opinion to Iceland for non-incorporation of Regulation 2016/1006 amending Regulation (EU) No 255/2010**

The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31(1) of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to take the measures necessary to incorporate the Act referred to at point 66wi of Annex XIII of the Agreement on the European Economic Area (Commission Implementing Regulation (EU) 2016/1006 of 22 June 2016 amending Regulation (EU) No 255/2010 as regards the ICAO provisions referred to in Article 3(1) ), as adapted to that Agreement by Protocol 1 thereto, as such into its national law, as Decision No. 100/17/COL.
