### **2. Case 75498: College Decision 078/18/COL - Complaint against Norway concerning alleged breach of Directive 2002/46 on food supplements and Article 11 EEA**

The College adopted a Decision to close a case on Iceland's failure to take the measures necessary to implement the Act referred to at point 4zrz of Chapter XVIII of Annex II of the Agreement on the European Economic Area (Directive 2014/53/EU of the European Parliament and of the Council of 16 April 2014 on the harmonisation of the laws of the Member States relating to the making available on the market of radio equipment and repealing Directive 1999/5/EC ), as adapted to that Agreement by Protocol 1 thereto, into its national law and/or its failure to notify the Authority forthwith of these measures, as Decision No. 080/18/COL.

**6. Case 81083: College Decision 077/18/COL - Closure Decision - Follow-up case on the implementation of the EFTA Court's judgment in Case E-18/16 concerning Iceland's non-implementation of Regulation 98/2013**
