The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31(1) of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to take the measures necessary to incorporate the Act referred to at point 1zzj of Chapter XXI of Annex II of the Agreement on the European Economic Area (Commission Delegated Regulation (EU) 2016/364 of 1 July 2015 on the classification of the reaction to fire performance of construction products pursuant to Regulation (EU) No 305/2011 of the European Parliament and of the Council), as adapted to that Agreement by Protocol 1 thereto, as such into its national law, as Decision No. 013/17/COL.

The College agreed that the competent College member would dispatch the reasoned opinion to Iceland.
