2. Case 81025: College Decision 165/17/COL - Reasoned opinion to Iceland for non-incorporation of Regulation 2017/193 regarding entries for Ukraine in the list of third countries from which the introduction of certain commodities into the Union is authorised

Document 872967

The College adopted a Decision to deliver a reasoned opinion in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice concerning the failure by Iceland to make part of its legal order Commission Implementing Regulation (EU) 2017/193 of 3 February 2017 amending Annex II to Decision 2007/777/EC and Annex I to Regulation (EC) No 798/2008 as regards the entries for Ukraine in the lists of third countries from which the introduction of certain commodities into the Union is



authorised in relation to highly pathogenic avian influenza as incorporated by simplified procedure during the first quarter of 2017, as Decision No. 165/17/COL.

The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice concerning the failure by that State to make part of its legal order (Commission Implementing Regulation (EU) 2017/481 of 20 March 2017 amending Annex I to Regulation (EC) No 798/2008 as regards the entry for the United States in the list of third countries, territories, zones or compartments from which certain poultry commodities may be imported into or transit through the Union in relation to highly pathogenic avian influenza), as incorporated by simplified procedure during the first quarter of 2017, as Decision No. 166/17/COL.

The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice concerning the failure by that State to make part of its legal order (Commission Implementing Regulation (EU) 2017/384 of 2 March 2017 amending Annexes I and II to Regulation (EU) No 206/2010 as regards the models of veterinary certificates BOV-X, OVI-X, OVI-Y and RUM and the lists of third countries, territories or parts thereof from which the introduction into the Union of certain ungulates and of fresh meat is authorised), as incorporated by simplified procedure during the first quarter of 2017, as Decision No. 170/17/COL.

The College agreed that the competent College member would dispatch the reasoned opinion to Iceland.

The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice concerning the failure by that State to make part of its legal order (Commission Implementing Regulation (EU) 2017/186 of 2 February 2017 laying down specific conditions applicable to the introduction into the Union of consignments from certain third countries due to microbiological contamination and amending Regulation (EC) No 669/2009), as incorporated by simplified procedure during the first quarter of 2017, as Decision No. 167/17/COL.

The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31(1) of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to take the measures necessary to incorporate the Act referred to at point 46c of Chapter I of Annex II of the Agreement on the European Economic Area (Commission Implementing Regulation (EU) 2016/1825 of 6 September 2016 amending Implementing Regulation (EU) No 901/2014 with regard to the administrative requirements for the approval and market surveillance of two- or three-wheel vehicles and quadricycles), as adapted to that Agreement by Protocol 1 thereto, as such into its national law, as Decision No. 168/17/COL.

The College agreed that the competent College member would dispatch the reasoned opinion to Iceland.

7. Case 80756: College Decision 169/17/COL - Reasoned opinion to Iceland for non-incorporation of Regulation 2016/1824 as regards vehicle functional safety requirements, to vehicle construction and to environmental and propulsion unit performance requirements

The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31(1) of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to take the measures necessary to incorporate the Act referred to at point 46a of Chapter I of Annex II of the Agreement on the European Economic Area (Commission Delegated Regulation (EU) 2016/1824 of 14 July 2016 amending Delegated Regulation (EU) No 3/2014, Delegated Regulation (EU) No 44/2014 and Delegated Regulation (EU) No 134/2014 with regard, respectively, to vehicle functional safety requirements, to vehicle construction and general requirements and to environmental and propulsion unit performance requirements), as adapted to that Agreement by Protocol 1 thereto, as such into its national law, as Decision No. 169/17/COL.

The College agreed that the competent College member would dispatch the reasoned opinion to Iceland.
