## 2. Case 79428: College Decision 027/17/COL - Letter of formal notice - Follow-up to Case E-35/15 - Port reception facilities (Norway)

The College adopted a Decision to issue a letter of formal notice to Norway for failure to comply with the judgment by the EFTA Court in Case E-35/15 — Failure by an EFTA State to fulfil its obligations — Directive 2000/59 on port reception facilities for ship-generated waste and cargo residues, as Decision No. 027/17/COL.

# 3. Case 79516: College Decision 020/17/COL - Reasoned opinion to Iceland for non-incorporation of Regulation 2016/355 as regards specific requirements for gelatine, collagen and highly refined products of animal origin intended for human consumption

The College adopted a Decision to deliver a reasoned opinion to Iceland in accordance with Article 31(1) of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to take the measures necessary to incorporate the Act referred to at point 17 in Part 6.1 of Chapter I of Annex I of the Agreement on the European Economic Area (Commission Regulation (EU) 2016/355 of 11 March 2016 amending Annex III to Regulation (EC) No 853/2004 of the European Parliament and of the Council as regards the specific requirements for gelatine, collagen and highly refined products of animal origin intended for human consumption ), as adapted to that Agreement by Protocol 1 thereto, as such into its national law, as Decision No. 020/17/COL.
