### 5. Case 75527: College Decision 059/17/COL - Letter of formal notice - Norway - Follow-up of CJEU Ruling in case C-628/11 International Jet Management GmbH

The College adopted a Decision to issue a letter of formal notice to Norway for failure to comply with Regulation (EC) No 1008/2008 and Article 4 EEA by maintaining in force a provision that requires prior authorisation for EEA licensed air carriers to conduct non-scheduled intra-EEA flights and a provision that precludes air carriers licensed in an EEA State other than Norway to carry out non-scheduled flights to States outside the EEA., as Decision No. 059/17/COL.
