### **2. Case 81083: College Decision 029/18/COL - Letter of formal notice - Follow-up case on the implementation of the EFTA Court's judgment in Case E-18/16 concerning Iceland's non-implementation of Regulation 98/2013**

The College adopted a Decision to issue a letter of formal notice to Iceland in accordance with Article 33 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to comply with the judgment by the EFTA Court in Case E-18/16 concerning Iceland's non-incorporation of Regulation 98/2013 on the marketing and use of explosives precursors, as Decision No. 029/18/COL.

### **3. Case 79187: College Decision 030/18/COL - Letter of formal notice - Follow-up of the EFTA Court Decision E-19/15 regarding the Trade Act**

The College adopted a Decision to issue a letter of formal notice to Liechtenstein in accordance with Article 33 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to comply with the judgment of the EFTA Court of 10 May 2016 in Case E-19/15 regarding the Liechtenstein Trade Act, as Decision No. 030/18/COL.

The College adopted a Decision to deliver a reasoned opinion to Liechtenstein in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice concerning Liechtenstein's failure to fulfil its obligations arising from Articles 2(2)(a) and 7(2) of Directive 2004/38/EC considering third-country national family members of EEA nationals as no longer fulfilling the conditions for the granting of a residence permit and revoking those permits in the situations where the spouses have initiated divorce proceedings, as Decision No. 031/18/COL.

### **5. Case 81665: College Decision 028/18/COL - Decision pursuant to Article 14(1) of Regulation 561/2016 to grant Norway an exception from the rules on driving and resting times**

The College adopted a Decision to grant Norway an exception from the application of Article 8(6) of the Act referred to at point 24e in Chapter II of Annex XIII to the EEA Agreement, Regulation (EC) No 561/2006 of the European Parliament and of the Council of 15 March 2006 on the harmonisation of certain social legislation relating to road transport and amending Council Regulations (EEC) No 3821/85 and (EC) No 2135/98 and repealing Council Regulation (EEC) No 3820/85, as adapted to the EEA Agreement by Protocol 1 thereto, in conformity with Article 14(1) of the Act, to drivers participating in a charity truck run taking place on Saturday 9 June 2018, as Decision No. 028/18/COL.
