The College adopted a Decision to deliver a reasoned opinion to Norway in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's breach of Article 36 of the EEA Agreement by maintaining in force the requirement to submit to the Norwegian authorities specified information on all contracts concluded between Norwegian based recipients of services and providers of services from other EEA States with a value of at least a certain amount expressed in NOK at the latest within 14 days of commencement of the work in Norway ("the reporting obligation"), as Decision No. 104/18/COL.

The College agreed to inform the public by means of a press release.
