3. **Case 71837: Non-incorporation by Iceland of Regulation (EC) No 559/2011 (maximum residue levels for captan, carbendazim, cyromazine, fenamiphos, thiophanatemethyl, ethephon, triasulfuron and triticonazole in or on certain products)**

The College adopted the decision to issue a letter of formal notice to Iceland for failure to incorporate the Act referred to at point 40 of Chapter II of Annex I and in point 54zzy of Chapter XII of Annex II of the Agreement on the European Economic Area (*Commission Regulation (EU) No 559/2011 of 7 June 2011 amending Annexes II and III to Regulation (EC) No 396/2005 of the European Parliament and of the Council as regards maximum residue levels for captan, carbendazim, cyromazine, ethephon, fenamiphos, thiophanate-methyl, triasulfuron and triticonazole in or on certain products*), as adapted to the EEA Agreement by Protocol 1 thereto, into its national law and its failure to notify the Authority forthwith thereof, as **Decision No. 214/12/COL**

4. **Case 70933: Non-compliance by Norway with Directive 2005/29 on unfair commercial practices**

The College adopted the decision to issue a letter of formal notice to Norway for failure to fulfil its obligations arising from the act referred to at point 7g of Annex XIX of the Agreement on the European Economic Area (*Directive 2005/29/EC of the European Parliament and of the Council of 11 May 2005 concerning unfair business-to-consumer commercial practices in the internal market and amending Council Directive 84/4*), by maintaining in force Section 18, first paragraph, of the Norwegian Act No. 2 of 9 January 2009 relating to the Control of Marketing and Contract Terms and Conditions, etc. (*Lov nr. 2 av 9. januar 2009 om kontroll med markedsføring og avtalevilkår mv. "the Marketing Control Act"*), as **Decision No. 215/12/COL**

5. **Case 67474: Non-compliance by Norway with Article 4 of Directive 1999/37/EC concerning the use of temporary licence plates for motor vehicles issued in another EEA State**

The College adopted the decision to deliver a reasoned opinion to Norway, in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice, concerning Norway's breach of Article 11 of the EEA Agreement and of the Act referred to at Annex XIII point 24c to the EEA Agreement (*Council Directive 1999/37/EC of 29 April 1999 on the registration documents for vehicles*), by maintaining in force Section 2-7 of Regulation No. 92, as interpreted and applied by the Norwegian competent authorities, as **Decision No. 216/12/COL**
