2. Case 80570: College Decision 273/21/COL - Closure Decision - Water Framework Directive complaint against Norway regarding Rana Gruber AS

The College adopted a Decision to close a complaint case arising from an alleged failure by Norway to comply with Directive 2000/60/EC of the European Parliament and of the Council of 23 October 2000 establishing a framework for Community action in the field of water policy, as Decision No. 273/21/COL.



3. Case 78448: College Decision 274/21/COL - Closure Decision - Water Framework Directive - Complaint against Norway regarding dumping of mining tailings in Repparfjord

5. Case 78085: College Decision 277/21/COL - Letter of formal notice - Complaint against Norway concerning the award of exclusive rights for collection and treatment of waste

The College adopted a Decision to issue a letter of formal notice to Norway in accordance with Article 31 of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice for that State's failure to fulfil its obligations under Articles 1(1), 4(c) and 11 of Directive 2014/24/EU of the European Parliament and of the Council of 26 February 2014 on public procurement and repealing Directive 2004/18/EC, referred to at point 2 of Annex XVI to the Agreement on the European Economic Area, read in conjunction with Title II of that Directive; in relation to a partnership agreement entered into in 2019 by the owner municipalities of Midtre Namdal Avfallsselskap IKS, awarding a public service contract for the collection, transport, handling and trade of municipal commercial waste directly to that inter-municipal company, as Decision No. 277/21/COL.

6. Case 83031: College Decision 272/21/COL - Letter of formal notice to Iceland concerning periodic training for professional drivers set out by Directive 2003/59/EC

The College adopted a Decision to issue a letter of formal notice to Iceland for that State's failure to fulfil its obligations arising from Article 10 of Directive 2003/59/EC by issuing driving licenses marked with the Community 95 code pursuant to Article 10 of the Directive, irrespective of whether the applicants had in fact concluded the compulsory CPC periodic training; and that State's failure to fulfil its obligations arising from Article 3 of the EEA Agreement, as Decision No. 272/21/COL.
