### **2. Case 92518: College Decision 053/26/COL - Court referral - Norway - Non-implementation of Directive 2019/1161 as regards the promotion of clean and energy-efficient road transport vehicles (*Environment - Air*)**

The College adopted a Decision to bring a matter against Norway before the EFTA Court in accordance with Article 31(2) of the Agreement between the EFTA States

on the Establishment of a Surveillance Authority and a Court of Justice due to the failure by Norway to fulfil its obligations under the Act referred to at point 21av of Annex XX to the Agreement on the European Economic Area (*Directive (EU) 2019/1161 of the European Parliament and of the Council of 20 June 2019 amending Directive 2009/33/EC on the promotion of clean and energy-efficient road transport vehicles*), as adapted by Protocol 1 to that Agreement, and under Article 7 of the EEA Agreement, by failing to adopt the measures necessary to fully implement the Act within the time prescribed, or in any event, by failing to inform the EFTA Surveillance Authority thereof, as Decision No. 053/26/COL.

**3. Case 93654: College Decision 055/26/COL - Court referral - Iceland - Non-incorporation of Regulation 2019/1010 as regards the alignment of reporting obligations in the field of legislation related to the environment (*Environment*)**

The College adopted a Decision to bring a matter against Iceland before the EFTA Court in accordance with Article 31(2) of the Agreement between the EFTA States on the Establishment of a Surveillance Authority and a Court of Justice due to the failure by Iceland to adopt the measures necessary to make the Act referred to at point 7 of Chapter XIII and point 9c of Chapter XVII of Annex II to the EEA Agreement, as well as points 1h, 1i, 1j, 32 and 32g of Annex XX to the Agreement on the European Economic Area (*Regulation (EU) 2019/1010 of the European Parliament and of the Council of 5 June 2019 on the alignment of reporting obligations in the field of legislation related to the environment, and amending Regulations (EC) No 166/2006 and (EU) No 995/2010 of the European Parliament and of the Council, Directives 2002/49/EC, 2004/35/EC, 2007/2/EC, 2009/147/EC and 2010/63/EU of the European Parliament and of the Council, Council Regulations (EC) No 338/97 and (EC) No 2173/2005, and Council Directive 86/278/EEC*), as adapted by Protocol 1 to the Agreement, part of its internal legal order, as Decision No. 055/26/COL.
